Pearson Edexcel, also known as just Edexcel, is one of England, Wales and Northern Ireland's five(5) main examination boards, and is wholly owned by Pearson, the world's largest education publishing and technology company which is part of Pearson PLC, the global publisher and owner of Penguin, Financial Times and Pearson College, London. Pearson offers a variety of qualifications, including A levels (GCEs), GCSEs and the BTEC suite of vocational qualifications. Pearson Edexcel operates internationally, awarding over 1.5 million certifications to students around the world every year and marks the UK National Curriculum assessments.

## Pearson BTEC Diplomas

Pearson BTEC qualifications provide a practical, real-world approach to learning and skills development alongside key theoretical background. They are vocational/work-related qualifications that are exclusively offered by Edexcel. BTECs range from Entry Level to Level 8 (postgraduate level) on the National Qualifications Framework (NQF), offering a progression route across all levels, starting with BTEC Firsts and Higher National Diploma to the Postgraduate level. They are developed in consultation with industry and professionals, with the aim of being relevant, progressive and recognised global qualifications by professional bodies, employers and universities alike.

# Pearson Global University Progression Agreements

Pearson BTECs are growing qualification with very high acceptance by universities and employers alike. Almost all UK Universities accept Pearson BTEC qualification for advanced placement in the Bachelor's and Master's programmes. Articulations are established with numerous colleges and universities world-wide that provide easy acceptance and progression route for its students transiting to complete the final year(s) of the degree with a university of choice. In 2005/06, 323,000 students studied BTECs at college and schools; 23,000 studied BTECs at university; and 14,000 employees studied a BTEC while at work. Today (2013) this has doubled.

Programmes offered by Pearson are accredited by the UK Office of Qualification and Examinations Regulations (Ofqual) and the British Council. BTEC level 5 diplomas are generally accepted for advanced placements into the second year of the three years British University System and into year two and half of the four year US, Australian, Dubai, and Canadian University System. The Level 7 diplomas are widely accepted into final year of the MBA Degree.
